



WRITERS FOR THE NAST PROJECT “DEVELOPMENT OF A PHILIPPINES STI FORESIGHT AND 30-YEAR STRATEGIC PLAN 2019-2050”

The National Academy of Science and Technology, Philippines (NAST PHL) was tasked to implement the project “Development of a Philippine STI Foresight and 30-Year Strategic plan (2019-2050)” The NAST STI Foresight 2050 (*Pananaw 2050*) is a national interdisciplinary, transdisciplinary and participatory planning device with the goal to strategically develop the Philippines’ scientific capital (governance, institutions, talent, information infrastructure, public understanding) in the next 30 years to produce systems, processes and goods for inclusive growth, sustainability and competitiveness. The foresight will provide the context to guide our country’s STI community and other knowledge -based sectors in their strategic planning and thus provide focus for the country’s development. The existing AMBISYON 2040 which outlines the Filipinos’ vision for a “*Matatag, Panatag, at Maginhawang Kinabukasan*” is considered as a takeoff point for the foresight. “*Pananaw 2050*” will promote the science, technology and innovation support for the future that the Filipinos envision in 2040 and beyond i.e. 30 years from now. We are hiring writers to write and/or edit papers on the following:

1. Brief background/ overview on the topic or area/ sub-theme
2. General trend/status of STI in the Philippines in the area/sub-theme (strength and weaknesses)
3. Foresight: Insight/Outlook in to the future needs of Filipinos/ Philippines and potential STI support for these future needs
